 - 1. Your first and last name
 - 2. Your home address
 - 3. When you hear your name announced during the Public portion of the meeting, you may address the Board.
 - 4. You will be given 5 minutes to complete your comments.
 - 5. After your 5 minutes expires, your microphone will be muted to allow others an opportunity to address the Land Use Board.
